Dear Parents,

It is now time to begin preparations for the coming school year. You have already received communications concerning uniforms, books, and schedules, etc. This letter relates to finances.

Please see the attached financial statements which include tuition and registration fees, book fees, and student council fees.

FEEES FOR 1. TUITION, 2. REGISTRATION, 3. BOOKS, & 4. STUDENT COUNCIL MUST ALL BE WRITTEN AS SEPARATE CHEQUES (as they go into different accounts)

Our full tuition for the coming school year will be \$22,500. Your subsidized tuition of \$_____ is payable at your convenience as follows:

1. Two payments on September 1, 2018 and February 1, 2019 in the amount of \$_____; or
2. Four payments on September 1, 2018, December 1, 2018, March 1, 2019, and June 1, 2019 in the amount of \$_____; or
3. Ten payments of \$_____ on the first day of each month commencing September 1, 2018 to June 1, 2019.

For your convenience we accept Visa, MasterCard, and AMEX as payment for tuition with a rounded down 2% surcharge. **This surcharge will be withdrawn up front (\$_____)** and treated as a general donation to the school. A separate credit card authorization form is enclosed.

Please note: No student, without exception, will be admitted to class on September 4, 2018, without an ADMITTANCE CARD. ADMITTANCE CARDS will only be issued upon receipt of payment for all fees including tuition, registration, book, and student council.

Cheques and credit card arrangements must be received by the finance office **NO LATER** than Thursday, August 16th, 2018. Your cooperation with the finance office will be greatly appreciated in making the transition to the new school year as seamless as possible.

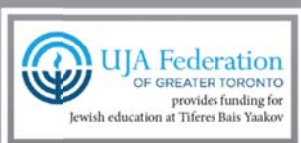
